Dear Community Behavioral Health Services Provider:

The purpose of this letter is to provide you with updated instructions for activating your Third Party Liability (TPL)/Medicare crossover enrollment. This will create a physician group, provider type 25, as required for reimbursement of TPL/ Medicare crossover claims.

For current 05 providers who wish to add crossover capability, please complete and submit the enclosed form to the fiscal agent for Florida Medicaid, ACS State Healthcare within 90 days of this letter and the crossover file will be activated automatically, without the need for a separate new location code application. The completed form captures information on the treating practitioners who will be providing crossover services for your group and will allow Florida Medicaid to link the individuals and their Medicare provider numbers to your group. 

For future enrollment of new community behavioral services groups, please complete and submit this new TPL/Medicare crossover form along with your completed Provider Type (PT) 05 application. Submitting them together will enable activation of a crossover file at the same time as the enrollment of the new PT 05 file. The enclosed TPL/Medicare crossover form will be made available on the fiscal agent's webpage at <http://floridamedicaid.acs-inc.com>. The TPL/Medicare crossover form is not required as part of the PT 05 enrollment, but may be submitted with the initial application or at any time after enrollment in the community behavioral services program is established.

Please note that Medicaid has discovered a significant barrier related to the activation of some TPL/Medicare crossover locations. The barrier is that 21% of the physicians who are affiliated with community behavioral services groups, provider type 05, have reached their limit of 15 group affiliations. Therefore, we are asking you to review the attached list of practitioners to determine if any that are associated with your agency have reached their limit on their group affiliations. If this is the case, please assist them in contacting their Area Medicaid office for assistance in removing any terminated links from their provider files to create space for new group links. If all of the group affiliations are active, then the individual provider may request an additional locator code on their base Medicaid provider number.

**All Community Behavioral Health Services providers who will be submitting Medicare or TPL crossover claims must complete this form.**

A Medicare number may only be cross referenced to one Medicaid number. If you have multiple Medicaid enrolled locations but only one Medicare number, you must choose one of your Medicaid locations to cross reference to the one Medicare number you have selected. All Medicare crossover and TPL claims, regardless of place of service, must be submitted using the Medicaid number you have chosen. NOTE: If the Medicare number you list below is already cross referenced to another Medicaid number, then by submitting this form you are authorizing Medicaid to end that cross reference and to establish a new cross reference to the Medicaid number listed below.
